NOTICE INVITING E-TENDER

E-Tender is hereby invited by the Barrackpore Police Commissionerate from bonafide Firms / Agencies for Procurement of 40 (Forty) units of Special Guardrails/ Barricades with 02 (Two) years maintenance in c/w different law and order duty and modern and modular Crowd-Control infrastructure for Barrackpore Police Commissionerate. Intended bidders are requested to submit their bids through E-Tender portal i.e. <https://wbtennders.gov.in> by following the terms and conditions of this NIT and as per the date and time schedule mentioned below.

SECTION I:-
REQUIREMENTS

Purchasing of 40 (Forty) Pieces of Special Guardrails / Barricades for different law and order duty and modern and modular crowd control infrastructure under Barrackpore Police Commissionerate.

Specification of Special Guardrails / Barricades describe as mention below -

MS Barrier 8ft.(H) X 5ft.(L) X 3ft.(D) made of 50 X 50 rectangular MS pipe main structure and one depth side MS wire mesh (Size: 2 inch X 2 inch.) Surrounding Eight place locking arrangement and nut-bolt fitting, bracket arrangement with fixing of "U" clamp with permanent post, under-ground locking arrangement to be done by you for installation of said barrier with back support of 50ft. 50 X 6 angles with base plate to be fixed under-ground with 4 inch.heavy duty wheel with enamel paint finish. Weight 130 Kgs. to 140 Kgs. approx.- 01 Pc.

- The amount of EMD to be submitted shall be Rs.30,000/-(Rupees Thirty Thousand) only.
- The amount of EMD to be submitted through online process as per finance department Order No. 3975-F(Y) dated - 28.07.2016.
- EMD of all unsuccessful tenderers deposited along with tenders will be refunded by as per norms and without any interest and the successful bidders/contractors who will get the job, EMD shall be released after completion of this e-tender process.
- Security Deposit to be deposited as per rules and order of the Government.
- In successful tenderer, the security deposit amount 10% will be deducted from the final bill or will be kept as bank guarantee to this office at the time of final payment.
- Security deposit shall be released after two years on satisfactory completion of the work.

- This quotation does not constitute a commitment to purchase.
- AOC will be issued to the eligible bidder after getting the necessary administrative & financial approval from the competent authority.

- Scanned Copy of EMD Exemption, if any.
- Scanned colour photocopy of the MS Portable Barriers with specification to be mentioned.
- Any interested bidders are instructed to inspect physically the same type of Special Guardrail/ Barricades at Barrackpore Police Lines with in the scheduled date and time mentioned above.

Opening of Technical Proposal

IF ANY DOCUMENT REQUIRED TO BE SUBMITTED FOR E-TENDER BY THE BIDDER IN HIS /HER TECHNICAL / FINANCIAL PROPOSAL , BUT NOT SUBMITTED OR IS FOUND BE TO IN EFFICIENT IN ANY MANNER AT ANY STAGE AFTER OPENING OF BID, THE BID MAY BE SUMMARILY REJECTED.

During evaluation, the committee may examine the original document as they are uploaded e-tender documents at any stage of Tender. If the said documents in original are not produced within the specified date and time, the bid proposals will be liable for rejection.

The e-Tender selection committee reserves the right to reject any application / bid without assigning any reason thereof.

Section IV: Draft proforma for Non – Conviction (in a form of affidavit in Rs. 10 Non – Judicial Stamp Paper)

The bidder shall provide an undertaking that the proprietor / promoter /director of the firm, its employee, partner or representative are not convicted by a court of law for offence involving moral turpitude in relation to business dealings such as bribery, corruption, fraud, substitution of bids, interpolation, misrepresentation, evasion or habitual default in payment of taxes etc. The firm does not employ a Government servant, who has been dismissed or removed on account of corruption. The firm has not been debarred, blacklisted by any govt. Ministry / department / local Govt./ PSU etc. In the last two years from scheduled date of opening of this E-Tender.
